The Path to Becoming a Chartered Accountant

1. Complete a 3-year SAICA endorsed Accounting Degree.
2. Complete a 1-year SAICA endorsed postgraduate Diploma in Accounting.
3. Complete a 3-year training contract with an accredited training provider (usually an Audit firm).
4. At the beginning of the training contract, the first of the SAICA professional exams is written, the initial assessment of competence (IAC).
5. At the end of the 2nd year of the training contract, the second of the SAICA professional exams is written, the Assessment of Professional Competence (APC).

As a contact student, this qualification is structured to be completed over 3 years. The maximum time for completing a qualification full-time is double the minimum time associated with the qualification, and for part-time an additional year is allowed.
