Qualification Description

The IIE Bachelor of Education (BEd) in Intermediate Phase Teaching (IPT) is an undergraduate professional qualification that is structured in accordance with the Department of Higher Education and Training's (DHET) Minimum Requirements for Teacher Education Qualifications (MRTEQ) (2015). It is also aligned with the new Higher Education Qualifications Sub-Framework's (HEQSF) guidelines.

This BEd Degree provides a fundamental and comprehensive education underpinned by subject knowledge in the specialist teaching of the following subjects:

- English First and First Additional Language Teaching
- First Additional Language Teaching (In either: IsiXhosa, IsiZulu, Northern Sotho, Setswana or Afrikaans)
- Natural Science and Technology Teaching
- Mathematics Teaching
- Social Sciences Teaching

The programme's focus on educational theory and methodology is therefore closely aligned with the requirements for a professionally qualified beginner teacher.

Who Is This Qualification Aimed At?

The IIE Bachelor of Education (BEd) in Intermediate Phase Teaching (IPT) is aimed at preparing graduates to teach learners from Grades 4 to 7. This Degree will equip Intermediate Phase

All applicants must have achieved a minimum of 50% in English on their NSC/SC/equivalent qualification – whether as a Home Language (HL) or First Additional Language (FAL) First Additional Language (FAL)* - All applicants to the BEd programmes must have obtained at least a Level 3 (40%) at the NSC or equivalent level, as a HL or FAL, in the language they are seeking to study as a FAL* in the BEd OR - Must demonstrate language proficiency (LP) in the selected FAL BEd language/s. FAL: Those who do not meet the FAL requirement on their NSC/ equivalent must demonstrate proficiency in the selected FAL Candidates who completed the IIE Higher Certificate in Communication Practice in the Education Discipline: In the case of those students who have already passed the Higher Certificate in Communication Practice in the Education Discipline, the English and FAL proficiency tests may be waived, as they would have successfully completed the English and FAL modules at NQF level 5, thus meeting the additional language requirements.

Teaching Experience

Teaching Experience (TE) involves placing student teachers in South African school environments where they engage in structured, practical learning and apply their theoretical knowledge in real classroom settings. This school-based Work-Integrated Learning (WIL) component is a critical requirement in all Faculty of Education qualifications. The TE weeks must take place in a suitable school (as determined by the institution) within reasonable range of one of the Emeris campuses.

Access into school-based work integrated learning (i.e. teaching experience). The following is important in this regard:

SACE Provisional Registration

All students registered for an initial teacher education qualification with Emeris are required to provisionally register with SACE.

Police Clearance Certificates

All students undertaking an academic qualification with a school-based WIL component will be required to have a valid police clearance on commencement of their Teaching Experience component in a school.

Access into school-based Teaching Experience

Access into school-based Teaching Experience in any academic year will be conditional upon meeting both of the following requirements:

- 100% Attendance in the Teaching Experience Module Lecture Sessions.
- 100% Submission rate for all module assessments in modules aligned to Teaching Experience.

Graduation and Completion Requirements for This Qualification

In order to be awarded this qualification, you must have achieved a minimum final year mark of fifty percent (50%) for all 49 modules in the curriculum.

As a distance (online) student, this qualification is structured to be completed over 6 years. The maximum time for completing a qualification full-time is double the minimum time associated with the qualification, and for part-time an additional year is allowed.

Where Assessments Are Written in Person

- For students based in South Africa, online students may select any Emeris campus as their Examination Centre.
- An alternative examination centre is only permissible for students studying abroad and those located in a province of South Africa where there is no IIE campus. If there is no IIE campus within reach, an alternative venue will need to be sourced by you. For non-IIE venues, there is an alternative venue levy per module.
