Timetables

Graduation and Completion Requirements for This Qualification

In order to be awarded this qualification, you must have achieved a minimum final year mark of fifty percent (50%) for all 8 modules in the curriculum.

As a contact student, this qualification is structured to be completed over 1 year. The maximum time for completing a qualification full-time is double the minimum time associated with the qualification, and for part-time an additional year is allowed.

System and Software Requirements

- The appropriate technology equipment and tools are essential.
- A reliable internet connection (we recommend 5-10 GB of data per month), your own device with at least Windows 8 or macOS 10.15 (Microsoft Office 365 is available as a free download for students), and Google Chrome, Microsoft Edge Chromium or Firefox.

- An uninterrupted power supply is also highly recommended.

- Should you wish to run Android Studio on your laptop – you will need the following:
 - Processor: i5/i7
 - RAM: 32
 - HDD: 500GB SSD
- All students in the IIE Higher Certificate in Mobile Application and Web Development will be provided with access to a Virtual Machine, where you will be able to run the software required for specific modules in your qualification. Students will be required to complete certain module specific assessments via their Virtual Machine.

Exams are written at an exam centre and in some instances online. These details will be specified in your Programme Assessment Schedule (PAS).
