Qualification Description

The IIE Postgraduate Diploma in Accounting provides the knowledge and skills required within the fields of Auditing, Financial Accounting, Management Accounting, Financial Management and Taxation, that affords a successful learner admission to the South African Institute of Chartered Accountant's Initial Assessment of Competence (IAC) examination.

The IIE Postgraduate Diploma in Accounting is presented for learners who wish to qualify as Chartered Accountants. The programme is therefore designed to align with the Competency Framework of the South African Institute of Chartered Accountants (SAICA). This Competency Framework provides the academic programme requirements, for entrance to the IAC, the first of two professional exams assessed for the Chartered Accountant professional qualification.

This qualification is designed to graduate students with the ability to think and act strategically, professionally and ethically and to contribute meaningfully to the Accounting and Business sector. The programme design thus facilitates the development of a well-rounded Chartered Accountant. Graduates have both the theoretical depth and the applied skills relevant to further study or to succeed in the world of work.

Minimum Admission Requirements	FIRST ATTEMPT STUDENTS	Note: <u>Students with a SAICA accredited undergraduate degree:</u> Applicants with a SAICA-accredited undergraduate degree must have completed all 4 core 3rd year subjects - Auditing, Financial Accounting, Management Accounting and Finance and Taxation - in the year immediately preceding the year in which they are admitted into the PGDip (Accounting). OR A successfully completed accountancy bridging programme and completed all 4 core subjects - Auditing, Financial Accounting, Management Accounting and Finance and Taxation - in the year immediately preceding the year in which they are admitted into the PGDip (Accounting).
	REPEAT ATTEMPT STUDENTS	Note: Students who have unsuccessfully attempted their PGDip (Accounting) or equivalent once, in the year preceding registration for PGDip (Accounting) at either The IIE or any other higher education provider, will be admitted into The IIE's PGDip (Accounting) programme on condition that their overall average for their first attempt of PGDip (Accounting) or equivalent was at least 40%. Students who have unsuccessfully attempted their PGDip (Accounting) or equivalent two times or more at either The IIE or any other higher education provider, will not be admitted into The IIE's PGDip (Accounting) programme.

FIAC8419	<u>Financial Accounting 4:</u> Financial Accounting 4 focuses on the application of International Financial Reporting Standards (IFRS) at an advanced level for companies and complex groups.	8	30

MFAC8419	<u>Management Accounting & Finance 4:</u> Management Accounting and Finance 4 aims to provide tools that support analytical reasoning that contribute to effective management and decision making in the context of real-world scenarios. Further Study Pathways

The path to becoming a Chartered Accountant:

1. Complete a 1-year endorsed Postgraduate Diploma in Accounting.
2. Complete a 3-year training contract with an accredited training provider (usually an audit firm).
3. At the beginning of the training contract, the first SAICA professional exams is written, the Initial Assessment of Competence (IAC).
4. At the end of the 2nd year of the training contract, the second of the SAICA professional exams is written, the Assessment of Professional Competence (APC).

Career Opportunities

The IIE Postgraduate Diploma in Accounting is endorsed by the South African Institute of Chartered Accountants (SAICA) and successful completion qualifies students to write the Initial Assessment of Competence (IAC), the first of SAICA's two professional exams.

The Chartered Accountant (South Africa) designation will open up career opportunities in a diverse and exciting range of business-related careers, including:

- Public practice
- Consulting in Taxation, Management Accounting, International Financial Reporting Standards and Auditing
- Finance and Management functions, including Financial Manager (FM), Chief Financial Officer (CFO) and Chief Executive Officer (CEO)
- Academia (teaching and learning, research and community-based involvement).

Timetables

This qualification is aimed at students who wish to complete full-time face-to-face studies for the duration of their qualification. This means that students are expected to be available Mon-Fri 8:00 – 17:00 throughout the day for class in the academic year depending on how the timetable is structured.

Students must also note that timetables remain subject to change throughout the academic year.

Graduation and Completion Requirements for This Qualification

It is important to note that students are required to pass all four subjects in one academic year to successfully graduate on the PGAC0801. Should you not achieve a minimum of fifty percent (50%) in all four modules, you will be required to repeat the qualification and will be permitted to register for one additional consecutive year to reattempt and pass all four modules on condition that your average for your first attempt of PGAC0801 (or equivalent) was at least forty percent (40%).
